Penelitian ini membahas perihal Konsep *Holding Company* dan bentuk perencanaan *Investment Holding Company* dalam perusahaan induk perusahaan. Jenis Penelitian hukum ini adalah yuridis normatif. Hasil Penelitian disini menunjukkan bahwa sejatinya pemakaian istilah *Holding Company* tidak ada undang-undang yang mengaturnya, serta menjelaskan bentuk *Holding Company* yang diterapkan pada PT. INALUM adalah *Holding Company* berbentuk *Operational Holding Company* dan bukan *Investment Holding Company*, karena *Investment Holding Company* tidak dikenal di Indonesia, pada hakikatnya di Indonesia belum adanya aturan Undang-undang yang spesifik mengatur perihal perusahaan grup (*Holding*). Dan peran Notaris dalam perencanaan pembentukan *Investment Holding Company* terkesan terpaksa karena masih berpegang pada dasar hukum UUPT yaitu pembuatan akta pendirian perseroan terbatas yang merupakan atau akan menjadi anak perusahaan, pada hakikatnya pada UUPT belum terdapat aturan spesifik mengenai perusahaan grup. Pemerintah dalam pembentukan *Holding* BUMN yaitu pada INALUM atau sering disebut dengan MIND ID merupakan upaya pemerintah dalam melindungi keuangan Negara.

ABSTRACT

Title : *Engineering Investment Holding Company in the Holding Company (An Analysis of the Establishment of PT. INALUM)*

This study discusses the concept of the Holding Company and the engineering form of the Investment Holding Company in the holding company. This type of legal research is normative juridical. The results of the research here indicate that the actual use of the term Holding Company does not have a law that regulates it, and explains the form of Holding Company applied to PT. INALUM is a Holding Company in the form of an Operational Holding Company and not an Investment Holding Company, because Investment Holding Companies are not known in Indonesia, essentially in Indonesia there are no specific laws governing group companies (Holding). And the role of a Notary in engineering the formation of an Investment Holding Company seems forced because it still adheres to the legal basis of the Company Law, namely the making of a deed of establishment of a limited liability company which is or will become a subsidiary company, in essence there are no specific rules regarding group companies in the Company Law. The government in establishing BUMN Holding, namely INALUM or often referred to as MIND ID is the government's effort to protect state finances.
