**Pengaruh Rasio Keuangan Terhadap Harga Saham Serta Tinjauannya Dari Sudut Pandang Islam (Studi pada Perusahaan Sektor Makanan dan Minuman yang Terdaftar di Bursa Efek Indonesia Periode 2016–2021)**

### **Uraian Abstrak**

Penelitian ini bertujuan untuk mengetahui pengaruh rasio keuangan dimana diukur dengan variabel *Current Ratio*, *Net Profit Margin*, *Debt To Equity Ratio*, *Total Assets Turnover* dan *Earning Per Share* terhadap Harga Saham pada perusahaan sektor makanan dan minuman yang terdaftar di Bursa Efek Indonesia periode 2016–2021. Populasi yang digunakan dalam penelitian ini yaitu sebanyak 29 perusahaan. Metode pengambilan sampel yang digunakan adalah metode *purposive sampling*, sehingga diperoleh 7 perusahaan dengan 6 tahun pengamatan (2016–2021). Jumlah data observasi sebanyak 42 sampel, data penelitian diperoleh dari website Bursa Efek Indonesia. Teknik analisis data yang digunakan adalah statistik deskriptif dan analisis regresi data panel menggunakan aplikasi *Eviews12*. Hasil penelitian menunjukkan bahwa secara parsial *Current Ratio*, *Net Profit Margin* dan *Earning Per Share* berpengaruh terhadap Harga Saham, *Debt To Equity Ratio* dan *Total Assets Turnover* tidak berpengaruh terhadap Harga Saham. Secara simultan *Current Ratio*, *Net Profit Margin*, *Debt To Equity Ratio* *Total Assets Turnover* dan *Earning Per Share* berpengaruh terhadap Harga Saham. Menurut sudut pandang Islam, aktivitas yang dilakukan terkait harga saham dan kinerja perusahaan tercermin dalam rasio keuangan diperbolehkan, namun harus sesuai dengan prinsip-prinsip Islam yang ditetapkan.

***The Effect of Financial Ratio on Stock Price and From Islamic Perspective (The case of Food and Beverage Sector Companies Listed on the Indonesia Stock Exchange in the 2016–2021 Period)***

### ***Abstract Description***

*This study aims to determine the effect of financial ratio as measured by the variables Current Ratio, Net Profit Margin, Debt To Equity Ratio, Total Assets Turnover and Earnings Per Share on Stock Prices in food and beverage sector companies listed on the Indonesia Stock Exchange for the 2016-2021 period. The population used in the study was 29 companies. The sampling method used is the purposive sampling method, so that 7 companies were obtained with 6 years of observation (2016-2021). The total observation data was 42 samples, the research data was obtained from the Indonesia Stock Exchange website. The data analysis techniques used are descriptive statistical analysis and panel data regression analysis using the Eviews12 application. The results showed that partially Current Ratio, Net Profit Margin and Earning Per Share has effect on Stock Price, Debt To Equity Ratio and Total Assets Turnover has not effect on Stock Price. Simultaneously Current Ratio, Net Profit Margin, Debt To Equity Ratio, Total Assets Turnover and Earning Per Share effect on Stock Price. According to the Islamic point of view, the activities carried out related to stock prices and company performance are reflected in the financial ratios allowed, but must be in accordance with established Islamic principles.*
